Founding Charter

In compliance with Section 8 (4) of Act CCIV of 2011 on national higher education and Section 3 (1) of Act XXXIV of 2020 on Marek József Foundation, the asset allocation to Marek József Foundation and the University of Veterinary Medicine Budapest, in line with the provisions for non-state-financed higher education institutions, I hereby publish the founding charter of the University of Veterinary Medicine Budapest as follows:

3. Purpose and legal status of higher education institution

- 3.1. The higher education institution's legally defined public benefit purpose is to conduct training and scientific activity in compliance with Section 2 (1) and (3) of Act CCIV of 2011 on national higher education (Nftv).
- 3.2. Based on Annex 1 of the Nftv, the higher education institution is a state-recognized higher education institution in Hungary, not a state-owned university.
- 3.3. Based on Section 4 (1d) of the Nftv, the higher education institution is a private higher education institution operated by a foundation registered in Hungary.
- 3.4. The higher education institution is a professionally independent and self-governing legal person according to Section 5 (1) of the Nftv.
- 3.5. In line with the provisions of Act CLXXV of 2011 on the Freedom of Association, Non-profit Status and the Operation and Support of Civil Organizations and based on the registry of the Educational Authority, the higher education institution is operated as a public benefit organization.

4. Activity of higher education institution

- 4.1. Based on Section 2 (1) of Act CCIV of 2011 on national higher education (hereinafter: Nftv) the higher education institution's core activity (legally defined public benefit activity) is to conduct training and scientific research.
- 4.2. Core activity of higher education institution:
- The institution shall conduct bachelor's, master's and undivided programmes as well as
 postgraduate specialist training courses and in the training area and at the training level
 defined in Section 6.3 and issue certificates thereof.
- Based on the permits to launch degree programmes issued by the minister in charge of higher education affairs in line with Act LXXX of 1993 on higher education, it shall conduct university-level training programmes in a phase-out system.
- It shall conduct higher vocational training programmes in a phase-out system, in the category of professions defined in Section 6.3, and issue degrees thereof.
- It shall conduct higher vocational training programmes in the training area defined in Section 6.3.
- It shall conduct doctoral programmes in the branch of science defined and Section 6.3, and issue doctoral degrees thereof.
- In compliance with the provisions of Act CXXXIX of 2005 on higher education, the Nftv, Act LXXVI of 1993 on vocational education and Act LXXVII of 2013 on adult education, the institution shall participate in the implementation of vocational training programmes that are not deemed as higher education as well as in other training tasks defined in the legal regulations pertaining to education.
- It shall conduct basic, applied and experimental research and development, science organization, technological innovation and other education-related research in the training areas and branches of science connected to the training programme.
- In compliance with the provisions of the Nftv, the institution shall participate in carrying out tasks within the framework of agriculture and veterinary healthcare as well as the management of nature conservation areas, according to the provisions of the pertinent specific legal regulations.
- It shall operate a educational plant, training farm and clinic for the purposes of practical training.
- The institution shall also contribute to the preparation of students for their lives as intellectuals by way of transmitting, cultivating and developing national and universal culture as well as transferring and developing knowledge in Hungarian and foreign languages.
- It shall develop and maintain its international relations that are necessary for a high-level implementation of education and research.
- It shall publish textbooks and lecture notes, and develop educational tools.
- In its own organization, it shall provide textbooks, lecture notes, library and laboratory services, campus accommodation, cultural and sport opportunities as well as other services that are aimed at promoting and facilitating the integration, healthy lifestyle and healthcare of students.
- As a library collecting items nationwide—, the institution's library shall participate in the supply of scientific and special libraries.
- It shall conduct activities in relation with the care of its employees, as required by the relevant legal regulations.
- It shall perform its infrastructural maintenance and development tasks within its own organization as a higher education institution.
- In order to carry out its tasks, it shall operate organizational units responsible for financial and internal audit activities, management, organizational and technical services as well as other functional organizational units that ensure seamless operation.
- It shall organize pre-enrolment preparation and other courses, and conduct language examinations.

- Within the branches of science connected to the training, it shall conduct cultural development, consulting and other activities.
- It shall produce, process and distribute agricultural and food industry products.
- It shall utilize the free capacities of the higher education institution's infrastructure, conduct research and development related business activities (publishing, planning, printing services, organizing Hungarian and international conferences, workplace hospitality services, catering, renting out educational facilities, sport facilities, dormitory rooms and research capacities).
- It shall conduct activities related to public collections and public culture.

4.4. Higher education institution's competence and area of operation: The territory of Hungary.

5. Organization and operation of higher education institution

- 5.1. The higher education institution's highest decision-making body is the Senate. The Senate's president is the Rector. The establishment and operation of the Senate is regulated by the Rules of Organization and Operation. The Senate identifies the higher education institution's training and research tasks as well as provides for the monitoring of their implementation. The Senate may debate any question, declare a position thereto as well as make recommendations.
- 5.2. The higher education institution is headed by the Rector who, by way of a public application process, is assigned and/or dismissed, based on the Senate's decision and the approval of the Foundation's Board, by the President of the Republic of Hungary for a period of up to five years in compliance with the relevant provisions of the Nftv. The fixed-term assignment can be extended once. With regard to the Rector, the employer's rights are exercised by the Maintainer.
- 5.3. The Rector and the Senate shall abide, and ensure that the institution abides, by the educational, scientific, cultural, innovational and economic guidelines identified by the Maintainer's Board in line with Hungary's and the University's interest.

6. Regulations pertaining to the higher education institution

- 6.1. Maximum number of students enrolled: 2.000
- 6.2. The higher education institution's
 - 6.2.1. organizational structure:

The higher education institution's organizational structure and order of operation, the division of management tasks and the provisions required by the legal regulations pertaining to internal and external relations are defined in the Rules of Organization and Operation.

The higher education institution shall submit the Senate-approved Rules of Organization

and Operation to the Board for approval.

As an educational and scientific research organizational unit, as per Annex 1, the higher education institution provides the operational facility for institutes, departments, non-independent departments, affiliated departments, doctoral schools, clinics, educational and training farms, an organization to conduct practical training for special service units as well as a separate research institute.

The higher education institution consists of institutes. The institutes organize the implementation of the tasks related to the training activities in one or more professionally connected training areas and training levels defined in Section 6.3.

In order to conduct its operational activities, the higher education institution maintains various functional organizational units such as economic, management, organization, controlling, technical services and other units required for operation.

The higher education institution has organizational units for such functions as social, cultural, sport, library, archive, museum, language acquisition, IT, publishing and production as well as workshops for practical training.

6.2.2. Assignment order of the Director of Finance:

The higher education institution's economic activities are organized and controlled by the Director of Finance who is employed as an executive. The Director of Finance manages assets, is responsible for preparing the budget proposal and controls the implementation of the approved budget. The budget proposal is accepted by the Senate and approved by the Maintainer. The Director of Finance exercises the rights related to financial commitments and payments. With regard to the Director of Finance, the employer's rights are exercised by the Rector, providing that the DF's commission is assigned and terminated by the Maintainer. The applications for the Director of Finance position are deliberated by the Senate before the Maintainer's approval.

6.4. In addition to the core activity, the institution conducts activities related to public education, public library service, public collections, healthcare, agriculture and rural development and other tasks: The higher education institution has workshops for library, archive, museum and practical training purposes as well as organizational units conducting production activities.

7. Non-profit status of higher education institution

- 7.1. With regard to conducting its activities, the higher education institution operates as a non-profit organization and/or may also conduct business activities in line with the provisions of the Nftv.
- 7.2. The profit achieved as a result of the higher education institution's business activity is not divided; it is allocated to its non-profit activity.
- 7.3. Supervisory Committee of Non-Profit Compliance
 - 7.3.1. The higher education institution's operation and financial management is supervised by the Supervisory Committee of Non-Profit Compliance which is not attached to the Senate.
 - 7.3.2. The Supervisory Committee of Non-Profit Compliance consists of three members, its chair and members are commissioned by the Maintainer for a fixed term of one year. The chair and the members may be commissioned multiple times.
 - 7.3.3. In the course of its activities, the Supervisory Committee of Non-Profit Compliance may request reports from the higher education institution's executive officers, information from the organization's employees as well as access to documents.
 - 7.3.4. The Supervisory Committee of Non-Profit Compliance determines its own agenda.
 - 7.3.5. The regulations pertaining to the higher education institution's non-profit compliance are detailed in the Rules of Organization and Operation.


8. Miscellaneous provisions

Effective as of 21 June, 2023.
