### 1. The object and the purpose of the agreement

1.1. The Parties agree that the present educational agreement has been concluded in order to offer educational programme at the UVMB for the student.

1.2. The course of study: veterinary medicine (the qualification attained through the educational programme is determined by the educational and graduation requirements).

1.3. Schedule of the educational programme: full-time

1.4. The educational programme is

a) organised by: UVMB,

b) at the premises (for educational purposes) of: UVMB,

c) for: 11 semesters, but not exceeding the number of semesters defined in the UVMB

1.5. Forms of assessment and supervision of students' performance attending in the educational programme are set out in the UVMB Academic regulations and requirements.

By executing this Educational Agreement, the Student represents they have become familiar with the University's internal policies, including the Study and Examinations Regulations, the Regulation of Disciplinary and Indemnification Cases, the Code of Ethics, the Regulation about accidents and all the regulations published on UVMB Academic regulations and requirements page - <https://univet.hu/en/education/about/uvmb-academic-regulations-and-requirements/>)

and recognises them as binding on themselves during the term hereof and/or the entire duration of the programme, and shall comply with them.



## 2. Financial provisions

- 2.1. Parties agree, that student is obliged to pay tuition fee for the studies.
- 2.2. Students are required to pay the tuition fee due for a particular semester by transfer within the date specified in the announcement relating to the particular semester.
- 2.3. All types of fees payable by the students are set out in the UVMB Academic regulations and requirements (<https://univet.hu/en/education/about/uvmb-academic-regulationsandrequirements/>).
- 2.4. Students who fail to pay the tuition fee subsequent to a demand of payment – unless they were not granted an extension of time for deferred payment – may not be allowed to subscribe to end-of-term examinations, to collect their course record books, to commence exams, to register for the ensuing semester, or to commence final examinations. In the event that UVMB does not provide the educational programme set out in this Agreement, the tuition fee shall have to be reimbursed. The payment obligations of the parties under this section shall not stipulate interests.

## 3. Other provisions

- 3.1. The Parties hereby declare that they will consider this Agreement to have been amended in line with any changes that may arise in the legislation and university policies governing the programme during the term of the contract in respect of this Agreement.
- 3.2. This Educational Agreement will be terminated on the date when the Student's legal relationship as student is terminated or, if the Student continues studies in the form of (partial) financing by a grant from the Hungarian state, on the date when the decision on this becomes final.
- 3.3. By signing this agreement, the student specifically approves that UVMB handles his/her personal data required for maintaining the student status during the necessary period and to the required extent and in regard to the provisions of the GDPR, and approves, that s/he can be contacted about UVMB's programme in newsletters during the studies. UVMB commits itself to use the provided personal data only for the purpose of supporting educational activities and for the purpose of sharing educational connected information.
- 3.4. Issues not regulated by this Contract shall be governed by the National Higher Education Act, Government Decree 87/2015 (9 April) on the implementation of certain provisions of the National Higher Education Act, Government Decree 51/2007 (26 March) on Grants Available for Higher Education Students and Fees Payable by Them.
- 3.5. The Parties conclude this Contract for a fixed term corresponding to the entire duration of the programme, and it shall take effect on the date it is signed by the Parties.

The Parties set their signature to this Agreement after having read and construed the terms hereof expressing that this Agreement reflect their true intentions in every way whatsoever.
